From the President

Just back from the ARRL 100th Anniversary Convention. What a thrill it was for me to be a part of it, and I have to thank you all, thank PCARS, for making that possible. I'll have more on the convention later in the newsletter, but I want to tell you that I am 100% rejuvenated on both PCARS and the ARRL! I hope that you'll join me in making the next 10 years of PCARS as exciting as the first 10 years has been. (By the way, next year will be the PCARS 10th Anniversary year. If you've got any ideas we should know about for making it "special", then send me an email and let me know what you've got on your mind.)

The ARRL is pretty much the reason that Amateur Radio continues to exist today. Without their influence through the past 100 years, we would have been legislated out of existence a long time ago. And don't think those are just hollow words! After WW I, the department of the Navy was all about not allowing Amateur Radio to restart after being shut down during the war. If it were not for the ARRL, they probably would have been successful. In recent times the ARRL fought for our right to have adequate antennas for our hobby and the public service we provide. PRB-1 was the resultant legislation that mandated that local building codes could not put us out of business. The Ohio Section leaders worked for years to get a similar law passed in Ohio, and were finally successful in just the recent past. It's now been announced that the ARRL



has pushed forth a new bill in Congress, that if passed, would force the same accommodation for antennas in "planned communities" (read developments with deed restrictions) as it does on local governments. This is a truly HUGE development.

HR-4969 - "the Amateur Radio Parity Act of 2014" was introduced to the current congress in June. You can find out all you need to know about it at http://www.arrl.org/hr-4969. Go there, find out about it and do what you can to support it. Start by writing your representatives and asking them to support the bill. Like I said, this is HUGE!

PCARS VE sessions are scheduled for 10:00 am on the first Saturday of every even numbered month. August 2nd, October 4th, December 6th

What to Bring to the Testing Session

- \$15 is the current test fee. We prefer the exact amount in cash or a check made out to: ARRL-VEC
- A government photo ID (driver's license or state ID card preferred). •
- Your Social Security Number or FCC Federal Registration Number. We are required • to submit either your Social Security Number (SSN) or your FCC Federal Registration Number (FRN) with your application. If you are upgrading, your FRN is on your current Amateur Radio license.
- A pen (black ink) and pencil (we can loan you either or both) •
- If you already have an Amateur Radio license: The original (and one copy) of any current (unexpired) • amateur radio operator's license issued to vou.
- If you've already passed a test: The original (and one copy) of any document that you will use to prove • you've already passed a test element. These documents may include:
 - 0 An unexpired Certificate of Successful Completion of Exam (CSCE) indicating the credit(s) earned indicating the credit(s) earned.
 - Original and copy of a pre-March 21, 1987 Technician license (this provides credit for the Element 3 0 [General] exam) - you must be currently licensed to get this credit.
- Expired License? Original and copy of your expired Amateur Radio License you must take and pass • element 2 to re-instate your license.



What is HR 4969?

In June, 2014 with Congressman Adam Kinzinger (IL-16) as the sponsor and Congressman Joe Courtney (CT-2) as co-sponsor, **HR 4969 - the ''Amateur Radio Parity Act of 2014''** - was introduced into the 113th Congress.

This bipartisan effort would direct the FCC to extend the "reasonable accommodation" provisions for Amateur Radio antennas to include all types of land-use regulation, including deed restrictions and restrictive covenants. **All the details can be found at:** <u>http://www.arrl.org/hr-4969</u>

Portage County Parks Headwaters Adventure Race Public Service Event

Saturday July 12th started the day with perfect weather for the annual Headwaters Adventure Race that took



place in Mantua and Hiram Townships. The race benefits the Portage Parks system and consists of a two mile run, followed by a ten mile bicycle race, and ending up with a five mile canoe race. ARES[®] of Portage County supported this event by providing communications at critical points such as turns at intersections and

river bridge observation and reporting, providing a sweep canoe with communicators, and shadow communicators to keep race officials at the start and finish line informed. Because of the river valley terrain not only having low

elevation but also shielded from line of site with the 146.895 repeater, two cross band repeaters were established to bridge the communications gap; one on Derthik's farm on Route 82 and one in Buchert Park in Mantua Village. Both of these cross band repeaters became key assets in allowing all of the volunteer communicators to be able to operate on the net with few problems.



Technology is great but the best widgets and radios in the world are useless without skilled communicators and the folks that volunteered to support this event were superb. Everyone demonstrated a level of professionalism that rivals that heard on public safety channels. 

DX/Contest SIG Report





LATE BREAKING NEWS..

CC&R's being looked into once again. As announced by the ARRL HR 4969 is being introduced into the U.S. House of Representatives.

In June, 2014 with Congressman Adam Kinzinger (IL-16) as the sponsor and Congressman Joe Courtney (CT-2) as co-sponsor, HR 4969 - the "Amateur Radio Parity Act of 2014" - was introduced into the 113th Congress. This bipartisan effort would direct the FCC to extend the "reasonable accommodation" provisions for Amateur Radio antennas to include all types of land-use regulation, including deed restrictions and restrictive covenants.



The event occurs within the beautifully kept grounds of **Conneaut Township Park and assembles** hundreds of re-enactors from across the United States and Canada. Remarkably, the 250 yard long beach and sloping adjacent terrain closely resembles Omaha Beach. Spectators will witness men, women, and their machines perform a living tribute to the veterans of WWII through dress, mock battles, and living history displays. Meet the real men and women that lived through these times. Last year the event host over 100 WWII veterans and it is hoped to have even more this year.

If you have never attended, the experience is called the most realistic and educational D-Day reenactment of the WWII era.

Admission is free but donations of any size are appreciated as the event is 100% funded by donations. If you attend, you will find the event just off Interstate 90 at Exit 241, 5 miles West of the Pennsylvania border.

In order to make room for more things to see, there is no longer any on-site parking at the park. There are ample parking areas around town served by speedy shuttles both Friday and Saturday. Mobility impaired persons and veterans of WWII-Vietnam can park at the CN Dock Company on Day Street, at which a wheelchair accessible van stops approximately every 15-20 minutes. Spectators can park at multiple lots around town. Watch for signs in town as you arrive for the most updated parking information, as some lots will close as they fill up quicker than others.



But that doesn't mean that nothing happened since then. OK, the experience we gained with the last DXpeditions in preparing and packing the sea freight makes it easier with the time. But nevertheless it was again a huge amount of work to get all ready to go.

Nearly the whole team met in Goch at the great station of DR1A where we packed all our equipment. Though we already have a good selection of radios, amplifiers and antennas on our stock, there are always new ideas coming up with each DXpedition which lead to even more equipment. So it was this time. For the planned contest operation as well as for the normal DXpedition we plan to set up two-radio setups which are sharing the available antennas. Also the antenna planning needed some brain power. For the high bands we will use both horizontal and vertical polarized monoband antennas for each band, because they were available and because they minimize interferences between the bands. Having a big field to set up antennas is good, but having the shack at one end of the property, you need long cable runs to feed all the antennas. Therefore over 1,500 meters of coax cable and another 1,400 meters of control cable went into the boxes. At the end of the weekend we had over 3 tons of equipment packed in nearly 60 different boxes. They will now be shipped from Germany to Australia mainland and further on to Lord Howe Island. This circumstance has relatively suddenly left us short of a team leader and committed operators, and therefore we have decided to completely re-organize the radio team. The first step is to identify a new team leader who is widely respected in the DXing community and experienced with organizing and leading DXpeditions to rare locations. The new team leader will have the authority and responsibility for re- building the radio team and for managing the amateur radio operations on Heard Island."



But, we met 3 other hams on the bus from the Atlanta, Ga. area, and they seemed like good fun so we spent the evening with them, including dinner at a tavern a couple blocks away from the convention center hotel. The hotel was very nice (way over priced) and the convention center was outstanding!

Thursday morning I headed out for an all day "Training Track". The one I paricipated in was called "Amateur Radio Leadership and Training Tools." The training track was hosted by Katie Allen, WY7KRA, former ARRL employee who

now resides in Wyoming. The first presentation was by Paul Beeman, W2PB, titled "Applying Project Management Strategies to Promote Successful Amateur Radio Ventures." This was a very scholarly

presentation on project management – way over my head for the most part. There were many similarities to the ICS (Incident Command System), so it was an interesting program. Next I was up doing a program titled "Building a Successful Club Program" which was primarily talking about what has made PCARS successful, and what club leaders needed to pay attention to to be successful. After lunch Bill

Edgar, N3LLR, did a presentation titled "Using Web Based Tools for Success." It was very interesting and we'll get some benefit out of that with some ideas that can be put to work immediately for PCARS. Finally, Jack Ciaccia, WM0G, Colorado SM did a talk titled "Leading Hams and Herding Cats. All It Takes is Food." He talked mainly about his experiences with ARES operations during wildfire season in Colorado. Interspersed between all of it, Katie Allen, WY7KRA, talked about using Social Media to promote both your club, and Amateur Radio in general. We had about 70 participants in this training track and I would say by our response it was a successful day for us.

Friday was a free day for me. I spent most of the day cruising the Exhibitors and picked up a few items I needed. It was all indoors in the



convention center. We saw Parky, KB8UUZ, and George, K3GP, PCARS members, manning the DXEngineering booth. In the afternoon Errol and I took the bus to Newington to visit the ARRL

"home office" and W1AW. It seemed just a little out of place, mixed into a primarily residential area. The antennas were impressive! The big surprise was how small W1AW actually is. But, there's a lot of station equipment crammed





into the space and no space is wasted! Lots of visitors were on the air, but I hadn't signed up in advance for that since I wasn't exactly sure when I would be out there. We went through the bottom



floor of the ARRL offices and labs. They have a very impressive display of radio equipment from early items built on wood chassis all the way up to the most current stuff available. The labs and workshops were most impressive. I believe they could put just about anything together there.

Friday night was the main banquet. Food was exceptionally good. Many dignitaries from other radio societies around the world presented the ARRL with plaques congratulating them on the 100th Anniversary. The highlite of the evening was definitely the Key-note speaker, FEMA Administator Craig Fugate, KK4INZ. Craig announced that he had just upgraded to the General Class Amateur Radio operator and then went on to speak about his experiences with Amateur Radio working with ARES in Florida. He talked about how that has had an influence on his position as FEMA Administrator and how important Amateur Radio is to the security and safety of our





nation. Craig is definitely a friend of amateur radio and an advocate to those in government.

Saturday was another day of cruising the exhibition hall and forums. All together between Friday and Saturday there must have been over 30 different

forums that you could attend. Many were standing room only! I attended an early Saturday morning forum on Radio Restoration and picked up a couple good tips there. Later I attended one on promoting

Amateur Radio via newspapers, radio, television and via the internet. My second presentation was Saturday right after lunch and was the same presentation I presented to PCARS at the July meeting. Again, it was well received, and I've received several emails after the convention from both of my talks. I was certainly proud to be able to present PCARS to the convention.



It was a once in a lifetime event. I would have gone regardless because I am a true believer that the ARRL does an excellent job promoting and protecting our interests. Errol was a fun guy to be travelling with, and I hope I get to go to the 200th Anniversary with him too!

A Huge Thank You for a Job Well Done!

We all know from the June Radiogram article Tom, WB8LCD wrote about the unexpected demolition of the 146.895 repeater antenna site. Fortunately for us, the Kent State University Police Department became aware of another radio system that suffered the same fate on that building. This awareness brought to mind that just possibly 146.895 could be damaged also and a call went out to one of our wonderful contacts & liaisons, Rick Patterson , K8GI. Rick phoned me and helped make arrangements to retrieve the equipment in the Leebrick Hall mechanical room before it was totally destroyed during the major building renovation.

While on the Leebrick Hall Roof I looked over to the KSU Library Building expecting to see the antennas we had installed previously for a future move. It is now the time for that move, well I know many of you may have ready Tom's article in June and heard we found the antennas had been removed from that building also during similar renovation there.

We received a go ahead from the KSU Police Department and Detective group to remove an old mount and install a new robust mount, a commercial Four Dipole Vertical and 220 link antennas. This was made possible due to Rick K8GI's involvement and looking out for the 895 repeater and assisting me in receiving permission for the install.

The permission was had and the next step was to inspect the newly renovated site and make plans for the new install. Tom, WB8LCD and myself used nearly the best part of a Saturday scoping out the existing feed lines that needed to be used and determining the





best route for the mount. Lots and lots of pictures and measurements were taken.

The next step was to order the steel necessary to build the mounts and to order the two antennas. I was able to purchase the 220 link antenna from work at DX Engineering for a

great price. The commercial DB-224E had to be ordered from a commercial radio supplier. I approached James, KD8VT who works for First Energy and he was able to receive a rather comfortable price from Tessco Communications through his relationship with them at work. Thanks to James, the antenna was on order and we were on our way.

The mounts, mast and standoff for the link antenna were built in my garage, once everything arrived and was ready a Saturday was scheduled for the work detail, and I do mean work!



Tom WB8LCD, Brian N8-Zed-P-S, James KD8VT, Mike KB8TUI and a little later on Russ NR8W found our way to the top of the 12 story building and then to the top of the elevator pent house roof with about 600 pounds of tools, antennas and mounts etc.

Oh, I almost forgot, the elevator only travels to the 10th floor during weekends so we had to walk the steps to the rest of the floors and an additional 30 foot climb of steps to the roof plus a 20 foot ladder to the antennas



site carrying all of that equipment. Oh and it gets better, Tom and Mike had to hike the main antenna up 13 flights of steps as it could not be carried on the elevator - it is 12 feet long even broken down in half. I think they arrived 45 minutes at the top after we did.

When we arrived at the top of the building and entered the equipment room we found the ladder we planned to use to fasten the mount to the wall was chained to some equipment. We pretty much figured our day was done. A quick call to Erica AE8YL an employee for the KSU Plant Engineering Department made some calls to her colleagues on duty and the chain was removed... the day was saved.

All told Mike KB8TUI, Tom WB8LCD, James KD8VT,

Brian N8-Zed P S (our resident pack mule), Russ NR8W and myself spent over 10 hours that day in a hot sun assembling the new transmitter site.

The following Wednesday, Brian and I decided to take a vacation day from work and spent an additional 7 hours at the top of the tallest building in Portage County. Working around a window installation crew we finished the majority of the final antenna install.

This project was much more than any one person could possibly complete, I feel very strongly in saying Thank you so much to Mike KB8TUI, James KD8VT, Tom WB8LCD, Brian N8ZPS, Russ NR8W and behind the scenes, Erica AE8YL and Rick K8GI without whom none of this would be possible.

Again Thank you all for the time, energy and abuse it took to undergo this project. This Crew can do anything!

Ohio QSO Party - August 23rd

I thought I would include a brief review of just a few rules for the Ohio QSO Party.

Objective: For Amateurs inside the state of Ohio to make contact with as many Amateurs as possible both inside and outside of Ohio. For Amateurs outside the state of Ohio to make contact with as many Ohio stations as possible. Non-Ohio stations may work only Ohio stations, while Ohio stations may contact anyone.

Period: The Ohio QSO Party occurs on the fourth Saturday of August. The contest period extends from 1200 EDT (Noon) to 2400 EDT (Midnight) (1600UTC Saturday until 0400UTC Sunday). All stations may operate the full twelve hours.

Bands & Modes: CW and SSB on 80, 40, 20, 15, and 10 meters. More on this later.

Category: K8BF would be entering as a Multi-Op entry.

We will be covering the complete rules during our OQP meeting. Watch your e-mail for more details to follow. For now, plan on coming out and taking part in the Ohio QSO Party with K8BF. Hope to see you there.
